# Summary

Highlights since May 2018	Outcomes
OpenUp, the natural history aggregator, submitted more than 5M new records coming from Naturalis Biodiversity Center in Leiden. The content includes digitised specimens but also natural history artwork like drawings and jewelry made from plants, animal sounds etc. Most of the content is Tier 4 and open for re-use.	New high quality data published in Europeana
Bildarchiv Foto Marburg improved the quality of its content from Tier 0 to Tier 2.	Already published content gets improved
Erfgoedplus, the regional aggregator from Belgium, provided a significant update to clean up Tier 0 data.	
Europeana Fashion and Europeana Sounds submitted updates for all their data following the objectives of their Data Quality Plans.	
Hispana made several improvements both metadata and contentwise.	
The National Library of France provided an update for all their data and submitted a lot of new audio, cartes, images, manuscripts, monographies and other CH objects.	Existing content gets improved with proper IIIF
The <i>National Documentation Centre</i> , the Greek national aggregator, submitted 2 new sets, one of which is covering the Ancient Olympic Games.	New content available in the portal

#### Overview

Currently Europeana.eu features content from 45 countries in 39 languages across more than 3,700 data providers. In total there are **58,229,213** objects available in Europeana.eu. Compared to May 2018, Europeana has **6,094,476 items more** in Europeana Collections. OpenUp, the natural history aggregator, has contributed significantly to increasing the amount of CH objects in the portal by submitting a huge amount of new records (more than 5M) coming from Naturalis Biodiversity Center in Leiden.

In line with Europeana Foundation's business plan and working towards its strategic plan 2015-2020, Europeana is working on improving the richness and the quality of the metadata present in the Europeana repository. This is being achieved by asking Europeana's partners to review the presence, quality and consistency of metadata fields, such as the description, title, date (created or issued), coverage (spatial or temporal). In addition to this Europeana is focusing on increasing the number of digital objects labelled with rights statements that enable re-use, and also on the provision of direct links to media files of high quality.

Important work completed by the Data Partner Services (DPS) team during the last three months include continuation of testing the new ingestion tool (Metis) and drafting of the Metis user guide, reviewing the Data Quality Plans (DQPs) for DSI-3 and working on the new plans for DSI-4 as well as concluding the work on the first iteration of the metadata component of the EPF. In June, almost all DPS team members were involved and contributed significantly to the Migration Collection Day that took place at the Instituto Cervantes in Utrecht.



## **Europeana Publishing Framework (EPF)**

Improvement of data quality: we aim to increase the percentage of Tier 2+ material to at least 40% of the total and the percentage of Tier 3+ material to at least 20% of the total by end of 2018. We now surpassed that goal of over 40% in tier 2+ material by 8% and our goal of 20% in tier 3+ material by 3.1%. A lot of this was due to the data updates mentioned above (Naturalis, Foto Marburg, newspapers, BnF, etc). About 25% of the material not compliant to the EPF has this year either been improved or depublished, bringing the EPF non compliant material down to a level of 17% of the total. It is still a challenge to measure tier progress consistently and regularly due to technical issues. With the launch of Metis including a new media service we expect these issues to be solved over the next few months.




## **Content in Europeana by Country - Top 15**

Looking at the country division of metadata throughout the digital objects available in Europeana.eu, the Netherlands provided the majority of the content increased by almost 5 million records, thanks to the data submitted by Naturalis. Germany is now the second biggest provider after depublishing two datasets with broken links coming from Arts Council Norway. Spain, United Kingdom and France show equally high numbers of contributions. On the other hand, countries contributing less than one per cent of the content are classified as 'Other' and include Estonia, United States Of America, Portugal, Lithuania, Romania, Latvia, Switzerland, Slovakia, Ireland, Bulgaria, Croatia, Luxembourg, Serbia, Malta, Cyprus, Russia, Israel, Iceland, Moldova, Turkey, Ukraine, Macedonia, Albania, Holy See (Vatican City State), Montenegro, Bosnia and Herzegovina.






